New Zealand has a new Firearms Registry. If you're a firearms licence holder, you have until 24 June 2028 to register your firearms. However, there are activating circumstances when you're required to provide information to the Registry within a shorter time frame. - This form is used to apply for approval of the sale and purchase of non prohibited arms items and ammunition by mail order or on the Internet.
- You may not take possession of any non-prohibited firearm, non-prohibited magazine, non-prohibited part, ammunition and/or pistol carbine conversion kit unless you have a current firearms or dealer licence.
- If you are purchasing an airgun, you need to be 18 years of age or older if you do not have a firearms licence.
